## Szaferman Lakind Launches 2018 Holiday Giving Campaign

[LAWRENCEVILLE, NJ, December 20, 2018] This holiday season, Szaferman Lakind is giving back to the community by providing donations to two local organizations, HomeFront and Womanspace, both located in Lawrenceville, New Jersey.

The firm sponsored the holiday wishes of 45 local children affected by homelessness in our area through HomeFront. Members of Szaferman Lakind provided toys, clothing, electronics and gift cards to fulfill the children's holiday wishes.

HomeFront works to end homelessness in Central Jersey by providing a variety of resources to the community. Services include: emergency shelter, transitional housing and permanent housing to over 400 people in Mercer County.

They also provide emergency food, free clothing, household goods and job placement and training. For children the agency offers pre-school, summer camps, after-school tutoring and other activities.

Szaferman Lakind also donated to Womanspace, another nonprofit organization in the Lawrenceville area. By collecting various toiletry items such as toothbrushes, toothpaste, shampoo, soap and lotion, the firm was able to provide for the basic needs of adults and children affected by domestic and sexual violence.

Womanspace works to prevent domestic and sexual abuse, protect families and change lives via empowerment and supportive services. The organization provides services and programs such as crisis intervention, emergency shelter, counseling and court advocacy.
