# FIRM OBTAINS \$6,500,000 JUDGEMENT AGAINST ASBESTOS SUPPLIERS

A Judge in New Brunswick, N.J. recently awarded \$6,500,000 to our client for pain, suffering and eventual death from the deadly cancer mesothelioma.

The client's mesothelioma was caused by direct and indirect exposure to asbestos fibers that Johns-Manville ("JM") used in the manufacture of various products at its plant in Manville, New Jersey. Because he grew up only a few blocks away from the JM plant, the client was environmentally exposed

throughout his childhood to airborne asbestos that was emitted daily from the facility.





In addition, our client's mother worked as a weaver at the JM plant. During that time she was exposed to asbestos dust which was brought home on her clothing, further exposing our client to asbestos fibers when he was a child.

After a hearing in June, NJ Superior Court Judge Ana Viscomi entered a judgment in favor of our client and his family to be paid by Anova Holding, AG and Becon, AG, who are foreign companies based in Switzerland that supplied asbestos to Johns-Manville from the 1950's into the 1980's, according to partner Bob Lytle.

#### PARTNER DAN SWEETSER PREVAILS IN THIEVERY TRIAL AGAINST GRANDDAUGHTER





On June 8, 2017, a Morris County Chancery Judge ruled in favor of our elderly client following a two-day trial in which Dan Sweetser proved that our client's adult granddaughter unlawfully took tens of thousands of dollars from her in 2011.

Due to an injury suffered by the elderly client in late 2010, she entrusted her financial affairs to her granddaughter. During this

time, the granddaughter pilfered tens of thousands of dollars from her grandmother until her misconduct was discovered a year later by her grandson, who immediately took steps to remove his sister from control over their grandmother's finances. After a two day trial before Morris County Presiding Chancery Judge Robert Brennan, the Court entered a verdict in favor of our client finding the granddaughter liable for breach of fiduciary duty, fraud and conversion. Judge Brennan ordered the granddaughter to pay damages in the full amount of our client's claim.

# FIRM MAKES NEW LAW IN AREA OF HIV PRIVACY PROTECTION

Working as a team, attorneys Craig Hubert, Keith Hovey, and Brandon Simmons successfully represented the plaintiff ["patient"] in Smith v. Datla, a case involving a physician's disclosure of his patient's HIV diagnosis to a third party without the patient's consent. The Appellate Division of the Superior Court of New Jersey rendered its decision in the plaintiff's favor on July 12 of this year, making new law in the process.

During a consultation, the defendant, Dr. Datla, disclosed the patient's HIV diagnosis (which had before this time been private) to a third party who was in the patient's hospital room at the time.

Following the disclosure, Szaferman Lakind filed suit on behalf of the patient advancing three theories of liability: medical malpractice, invasion of privacy, and violation of the AIDS Assistance Act. New Jersey recognizes four types of invasion of privacy actions, each with different statutes of limitations requiring a plaintiff to bring a claim within a certain time. The categories are as follows: intrusion (two year statute), public disclosure of private facts (the claim advanced in the Smith case, held to have a two year statute), false light (one year statute), and misappropriation (six year statute).

Prior to the Smith case, no appellate court in New Jersey had decided which statute of limitations applied to claims alleging public disclosure of private facts or for claims under the AIDS Assistance Act. The Appellate Division, in its precedential opinion, agreed with plaintiff, and his amici, the New Jersey State Bar Association, and the New Jersey Association for Justice, that these claims were subject to the two-year statute of limitations governing personal injury claims and not the one-year statute of limitations applicable to defamation claims as argued by the defendant. The statewide decision strengthens a patient's, and particularly an HIV patient's, privacy rights in his or her medical information.

# NEW JERSEY SUPREME COURT MODIFIES THE STANDARD TO RELOCATE CHILDREN OUTSIDE OF NEW JERSEY

On August 8, 2017, the New Jersey Supreme Court decided the case of <u>Bisbing v. Bisbing</u>, which changed the law pertaining to custodial parents attempting to relocate minor children outside of New Jersey.

Prior to the recent Bisbing holding, custodial parents seeking to move with minor children to another state had the burden of proving: (1) a good faith reason for the proposed move: and (2)

that the move would not be inimical to the child's best interests. However, the New Jersey Supreme Court has now departed from this two-part test, and, in its place, has instructed lower courts to conduct a "best interest" analysis to determine whether there is "cause" under <u>N.J.S.A. 9:2-2</u> (the statute prohibiting parents from removing children to another state) to permit the move. By adopting this new standard, our Supreme Court mandated that the same best interest standard be applied to all interstate relocation disputes in which the parents share legal custody, inasmuch as the best interest analysis previously applied only to those cases in which parties shared residential custody of the children.

The new best interest standard is presumably more difficult for a custodial parent to satisfy because the prior law merely required that custodial parents establish that the proposed move was not inimical (or, in other words, not harmful or detrimental) to the children. Custodial parents must now affirmatively establish that the move is in the child's best interest. Because the Bisbing holding is so recent, however, its impact remains to be seen.

# VIDEO CAMERAS IN PATIENT ROOMS? CRAIG HUBERT AND CLIENT ON WHYY-NPR RADIO

In December 2016, New Jersey Attorney General Christopher Porrino began the state-funded "Safe Care Cam" program – surveillance video cameras for residents in assisted living. Per Porrino, "The initiative is really designed to do two things – provide peace of mind to those New Jersey families who've entrusted the care of their loved ones to someone else and also to send a loud message to any unscrupulous providers or abusers... we're watching, and, if you abuse a patient, we will prosecute you to the fullest extent under the law."

To discuss the Safe Care Cam program, National Public Radio (NPR)'s Philadelphia affiliate, WHYY-FM reporter Jeanette Beebe, met with firm Partner Craig Hubert and Craig's client, Richie, who's mother suffered from dementia and fell and fractured her femur twice within three weeks while in assisted living. Advised Craig, "This was a mistake, and, quite frankly, if there had been a video camera in that room after the first fracture, the administration, the nurses, and all of the caregivers would have learned from the improper transfer procedure."
